

QUARTERLY REPORT ON
AMERICAN RESCUE PLAN (ARP)
EMERGENCY GRANTS TO STUDENTS
 Higher Education Emergency Relief Fund (HEERF III)
 January 10, 2022

The Higher Education Emergency Relief Fund III (HEERF III) is authorized by the American Rescue Plan (ARP), Public Law 117-2 which was signed into law on March 11, 2021. ARP funds are in addition to funds authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260 and the Coronavirus Aid, Recovery, and Economic Security (CARES) Act, Public Law 116-136.

An institution that previously received HEERF (I - CARES or II - CRRSA) funds was not required to apply for the HEERF III (ARP) Grant. Rather, “the terms, conditions, and requirements governing the institution’s use of these supplemental grant funds awarded pursuant to section 2003 of the American Rescue Plan Act of 2021 (ARP) (Pub. L. 117-2) (supplemental award or grant) by the U.S. Department of Education (Department) are governed by section 2003 of the ARP and 314 of the CRRSAA (Pub. L. 116-260) and the terms and conditions of the ["Supplemental Agreement"](#)

Great Bay Community College (GBCC) received notification of HEERF III (ARP) Grant Funding on May 12, 2021 and acknowledges that the \$1,799,172 student portion must be used to make “emergency financial aid grants to students (which may include students exclusively enrolled in distance education), which may be used for any component of the student’s cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care) or child care.”

WHO IS ELIGIBLE FOR THE EMERGENCY FINANCIAL AID GRANT FUNDS?

Students who are or were enrolled at Great Bay Community College during the COVID-19 national emergency, as Section 2003(7) of the American Rescue Plan Act (ARP) explains.

HOW WILL GREAT BAY COMMUNITY COLLEGE DETERMINE WHICH STUDENTS RECEIVE FUNDS?

GBCC will follow ARP requirements: “students who are or were enrolled in an institution of higher education during the COVID-19 national emergency are eligible for emergency financial aid grants from the HEERF, regardless of whether they completed a Free Application for Federal Student Aid (FAFSA) or are eligible for Title IV”.

To be considered for eligibility for the emergency grants, students are required to complete a simple application by logging into the Student Information System ([SIS](#)) to indicate categories (up to 8) of Coronavirus related financial impact. Application categories:

1. Tuition, Fees, Books & Supplies
2. Child Care
3. Food
4. Health Care (including Mental Health)
5. Housing
6. Internet Access
7. Technology
8. Utilities

Grants for Summer Semester: Credit students who selected the “Tuition & Fee” category were awarded an amount equal to \$215 per credit (full tuition rate, excluding fees). Selection of any of the other categories resulted in a \$250 per category award. Each eligible student also received an additional \$250. Individual student awards ranged from \$250 to \$4,150.

One eligible Non-Credit student selected three non- “Tuition & Fee” categories and was awarded \$250 per category.

Grants for Fall Semester: Credit students who selected the “Tuition & Fee” category were awarded an amount equal to \$215 per credit (full tuition rate) plus billed fees. Selection of any of the other categories resulted in a \$250 per category award. Individual student awards ranged from \$250 to \$6,495.

One eligible Non-Credit student was awarded \$1,000 for selecting the Tuition & Fee category, plus \$250 for six other categories selected. Total award \$2,500.

HOW WILL STUDENTS RECEIVE THEIR FUNDS?

SIS Applicants are asked to select a payment option during completion of the application, and provided with these instructions:

Option 1: Apply to my student account to pay tuition, fees, books for any semester billed on my account. (For LRCC & NHTI students only - will also apply to room & board charges.) Excess funds after paying off any student account balances will be refunded via check (mailed to address on file) or direct deposit.

Option 2: Pay directly to me via check (mailed to address on file) or direct deposit. Do not apply to my student account. I understand that I am still responsible for paying the balance on my account.

If you are awarded HEERF financial assistance and have chosen the direct payment method, the fastest way to receive funds is through direct deposit (DD).
